The proposed project activity is listed at schedule no. 3 (a) Metallurgical industries (ferrous & non-ferrous) & 1(d) Thermal Power Plants under Category "B" of the schedule of the EIA Notification, 2006 and general condition is applicable as Rajasthan SPCB has notified Bhiwadi as Critically Polluted Area (CPA) vide Letter No. CPCB/ IPC/ CEPI/ Rajasthan/ Action plan/ 8050 dt 12.10.2020, and the project site is falling within 5km i.e. 1.38 km (N) from Kushkera CEPI boundary and therefore the proposal being appraised at Central Level as Category 'A'.
- 3. The instant Proposal was considered and recommended in the 22^{nd} meeting of Expert Appraisal Committee (Industry-1 Sector) held during $30^{th}-31^{st}$ January, 2023. - 6. The EAC, in its meeting held during $30^{th} 31^{st}$ January, 2023, inter-alia, deliberated the following:
 - i. The instant proposal is for expansion in production capacity of MS billets from 1,32,000 TPA to 1,58,400 TPA & Rolling Mill for manufacturing of TMT Bars 2,00,000 TPA within existing facility of two induction furnace (20 Tonne each) with Reheating Furnace (30TPH).
- ii. The proposal falls under Category "B" of the schedule of the EIA Notification, 2006, however, general condition is applicable as Rajasthan SPCB has notified Bhiwadi as Critically Polluted Area (CPA) vide Letter No. CPCB/ IPC/ CEPI/ Rajasthan/ Action plan/ 8050 dt 12.10.2020, and the project site is falling within 5 km i.e. 1.38 km (N) from Kushkera CEPI boundary and therefore the proposal being appraised at Central Level as Category 'A'.
- iii. The EAC, constituted under the provision of the EIA Notification, 2006 comprising Expert Members/domain experts in various fields, examined the proposal submitted by the Project Proponent in desired format along with addendum to the EIA/EMP reports prepared and submitted by the Consultant accredited by the QCI/ NABET on behalf of the Project Proponent.



- iv. The EAC noted that the Project Proponent has given an undertaking that the data and information given in the application and enclosures are true to the best of his knowledge and belief and no information has been suppressed in the reports. If any part of data/information submitted is found to be false/ misleading at any stage, the project will be rejected and Environmental Clearance given, if any, will be revoked at the risk and cost of the project proponent.
- v. The EAC deliberated on the justification provided by the Project Proponent for appraisal of instant proposal under para 7(ii) of EIA Notification, 2006 in pursuance to the Ministry's O.M. dated 11.04.2022 and found it satisfactory. EAC is of the view that the instant project is qualifying the criteria mentioned in the Ministry's OM dated 11.04.2022 and accordingly appraise the project under expansion category.
- vi. The existing project was accorded environmental clearance by SEIAA, Rajasthan Vide File No-F1(4)/SEIAA/SEAC-Raj/Sectt/Project/Cat.7(d) B1 (15541)/2018-19, dated 01.04.2019 to produce 1, 32,000 TPA of M.S. Billets and 2,00,000 TPA TMT bar per annum by using two 20 tonne induction furnace and rolling mill. Consent to Operate for the existing unit was accorded by RSPCB vide F (HDF)/Alwar (Tijara)/6874(1)/2021-2022/3924-3944 dated 16.11.2021, which is valid till 30.09.2026.
- vii. The total project area is 3.22 ha. Land has been allotted on lease basis for 90 years from Rajasthan State Industrial Development and Investment Corporation Ltd (RIICO).and under the possession of the company. No additional land is required for proposed expansion project.
- viii. The nearest habitation to plant is Tapukara village located at 2.21 km away from the project site boundary in the NE direction.
 - ix. Total existing Water requirement is 40 m3/day and is being sourced from ground water. No additional water will be required for the proposed expansion.
 - x. Sahibi River (5.71 km WSW) and Chaundi Nadi (6.81 km S) are flowing within 10 km. radius of the plant site. The EAC is of the opinion that water bodies shall not be disturbed. Mitigation measures w.r.t. safeguarding the water bodies shall be implemented.
- xi. The Committee deliberated on the baseline data previously collected (March to May, 2018) at the time of EC dated 01.04.2019 and the fresh baseline data collected (March to May, 2022) during the instant application and observed that though the collected data shows the values beyond the NAAQ standards for some of the parameters in both the cases, however, there is decline in the values of the parameters in the baseline data of March to May, 2022 as compared to baseline data of March to May, 2018. Also, since the project falls under CPA, the monitored values are on higher side. Accordingly, the EAC deliberated on pollution load assessment reported by PP/Consultant and found it satisfactory. Considering the same, the proposal is appraised under para 7(ii)(a) of EIA Notification, 2006.
- xii. The EAC noted that total green area provided as per earlier granted EC is 33.23% of total project area i.e. 1.07 ha. Total 2675 no of trees to be planted as per EC. PP has already Planted 2000 trees. PP will further develop additional green belt of 0.21 ha for expansion project. Hence total green area after expansion will be 1.28 ha (40% of the total plot area). Thus total trees to be planted after expansion will be 1200.



- xiii. The committee deliberated details of carbon foot prints and carbon sequestration study w.r.t. proposed project and found them to be satisfactory.
- xiv. The Committee deliberated upon the certified compliance report of IRO, MoEFCC and found it satisfactory.
- xv. The Committee also deliberated on the earlier public hearing issues along with status of compliance of action plan submitted by the proponent to address the issues raised during the public hearing and is of the opinion that project proponent shall strictly comply with the targets and timelines of the action plan.
- xvi. The EAC deliberated on the proposal with due diligence in the process as notified under the provisions of the EIA Notification, 2006, as amended from time to time and accordingly made the recommendations to the proposal. The Experts Members of the EAC found the proposal in order and recommended for grant of environmental clearance.
- xvii. The environmental clearance recommended to the project/activity is strictly under the provisions of the EIA Notification 2006 and its subsequent amendments. It does not tantamount/construe to approvals/consent/permissions etc. required to be obtained or standards/conditions to be followed under any other Acts/ Rules/ Subordinate legislations, etc., as may be applicable to the project. The project proponent shall obtain necessary permission as mandated under the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981, as applicable from time to time, from the State Pollution Control Board, prior to construction & operation of the project.
 - 7. The EAC (Industry-1 Sector), in its 22nd meeting held on January 30 31, 2023, based on information & clarifications provided by the project proponent and after detailed deliberations recommended the proposal for grant of Environment Clearance subject to stipulation of specific and general conditions as detailed in the point below.
 - 8. The MoEF&CC has examined the proposal in accordance with the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the Expert Appraisal Committee (Industry-1 Sector) hereby decided to grant Environment Clearance for instant proposal of M/s SBF Ispat Private Limited under the provisions of EIA Notification, 2006 subject to the following specific conditions and general conditions:

A. Specific Condition:

- i. The existing environmental clearance granted by the by SEIAA, Rajasthan Vide File No-F1(4)/SEIAA/SEAC-Raj/Sectt/Project/Cat.7(d) B1 (15541)/2018-19, dated 01.04.2019 shall also remain active and the project proponent shall comply with all the terms and conditions mentioned in the EC dated 01.04.2019.
- ii. The project proponent shall comply with all the environmental protection measures and safeguards proposed in the documents submitted to the Ministry. All the recommendations made in the EIA/EMP in respect of environmental management, and risk mitigation measures relating to the project shall be implemented.
- iii. The project proponent shall utilize modern technologies for capturing of carbon emitted and shall also develop carbon sink/carbon sequestration resources capable of capturing more than emitted. The implementation report shall be submitted to the IRO, MoEF&CC in this regard.



- iv. In pursuance to MoEF&CC OMs dated 31st October, 2019 & 30th December, 2019 issued in compliance of the order of Hon'ble NGT in OA No. 1038/2018 dated 19th August, 2019, the compliance of all the conditions applicable to CEPI shall be implemented. Greenbelt shall be planned in 40% of the project area. CER allocation shall be 1.5 times of the normal calculated amount.
- v. Water requirement of 40 m³/day shall be sourced from ground water as proposed after obtaining necessary permission fromt the Competent Authority. However, PP shall explore the possibility of shifting to alternate source of water to reduce dependency on groundwater.
- vi. Following additional arrangements to control fugitive dust shall be provided:
 - a. Fog / Mist Sprinklers at all conveyors point and on bulk raw material storage area (at the transfer points) like Iron Ore, Coal and for Fly Ash and similar solid waste storage areas.
 - b. Proper covered vehicle shall be used while transport of materials.
 - c. Wheel Washing mechanism shall be provided in entry and exit gates with complete recirculation system.
- vii. All internal road and connecting road from project site to main highway shall be developed and maintained with suitable Million Axle Standard (MSA) as per the traffic load due to existing and proposed project.
- viii. All stockyards shall be having impervious flooring and shall be equipped with water spray system for dust suppression. Stock yards shall also have garland drains to trap the run off material.
 - ix. Performance test shall be conducted on all pollution control systems every year and report shall be submitted to Regional Office of the MoEF&CC.
 - x. Particulate matter emission from stacks shall be less than 30 mg/Nm³. Action plan submitted to limit the dust emission shall be strictly implemented.
- xi. CEMS shall be provided on all process stacks and the signal shall be received in plant control room for central control of APCDs installed in the plant
- xii. 85-90 % of billets shall be rolled directly in hot stage. RHF shall operate using only Light Diesel Oil as a fuel.
- xiii. Solid waste utilization
 - a. PP shall install a slag crusher to convert steel slag into aggregate for use in construction industry, fine sand for use as flux in steel plant, sand in brick making and as lime in cement making.
 - b. PP shall recycle/reuse 100 % solid waste generated in the plant.
 - c. Used refractories shall be recycled as far as possible.
- xiv. Sahibi River (5.71 km WSW) and Chaundi Nadi (6.81 km S) are flowing within 10 Km. radius of the plant site. A robust and full proof Drainage Conservation scheme to protect the natural drainage and its flow parameters; along with Soil conservation scheme and multiple Erosion control measures shall be implemented.
- xv. The proposed project shall be designed as "Zero Liquid Discharge" Plant. ETP shall be installed and there shall be no discharge of effluent from the plant. Domestic effluent shall be treated in Sewage Treatment Plant. MSW waste shall be treated in digester and recovered gas shall be used in the canteen.
- xvi. The company shall also undertake rain water harvesting measures as per the plan submitted in the EIA/EMP report and reduce water dependence from the outside source.



- xvii. The nearest habitation to plant is Tapukara village located at 2.21 km away from the project site boundary in the NE direction. Project Proponent shall take appropriate environmental safeguard measures to minimise the impact on the habitation of the locals. The company shall also include this location in its environmental monitoring programme.
- xviii. PP shall undertake village adoption and formulate Village Adoption program consisting of need-based community development activities, to develop them into model villages.
- xix. A proper action plan must be implemented to dispose of the electronic waste generated in the industry.
- xx. Three tier Green Belt shall be developed in at least 40% of the project area in a timeframe of one year with native species all along the periphery of the project site of adequate width and tree density shall not be less than 2500 per ha. Gap filling shall be undertaken and survival rate of green belt developed shall be monitored on periodic basis to ensure that damaged plants are replaced with new plants in the subsequent years. Compliance status in this regard, shall be submitted to concerned Regional Office of the MoEF&CC.
- xxi. Greening and Paving shall be implemented in the plant area to arrest soil erosion and dust pollution from exposed soil surface.
- xxii. Action Plan for firefighting system including provision for flame detectors, temperature actuated heat detectors with alarms, automatic sprinkler system, fixing the location of fire water tanks, separate power system for firefighting, involvement of qualified and trained fire personnel, nearest fire station & time required to reach the proposed site shall be prepared and implemented.
- xxiii. All the commitments made to the public during the Public Hearing/Public Consultation shall be satisfactorily implemented. The action plan based on the social impact assessment study of the project as per the EMP in accordance to the Ministry's OM dated 30.09.2020 shall be strictly implemented and progress shall be submitted to the Regional Office of MoEF&CC.
- xxiv. The Plastic Waste Management Rules 2016, inter-alia, mandated banning of identified Single Use Plastic (SUP) items with effect from 01/07/2022. In this regard, CPCB has issued a direction to all the State Pollution Control Boards (SPCBs)/Pollution Control Committees (PCCs) on 30/06/2022 to ensure the compliance of Notification published by Ministry on 12/08/2021. The technical guidelines issued by the CPCB in this regard is available at https://cpcb.nic.in/technical-guidelines-3/. All the project proponents are hereby requested to sensitize and create awareness among people working within the Project area as well as its surrounding area on the ban of SUP in order to ensure the compliance of Notification published by this Ministry on 12/08/2021. A report, along with photographs, on the measures taken shall also be included in the six monthly compliance report being submitted by the project proponents.
- xxv. The project proponent shall adopt the Clean Air practices like mechanical collectors, wet scrubbers, fabric filters (bag houses), electrostatic precipitators, combustion systems (thermal oxidizers), condensers, absorbers, adsorbers, and biological degradation. Controlling emissions related to transportation shall include emission controls on vehicles as well as use of cleaner fuels. Sufficient numbers of additional truck mounted Fog/Mist water cannons shall be procured and operated regularly inside the project premises and also in the surrounding villages to arrest suspended dust in the atmosphere.

B. General conditions:

I. Statutory compliance:

i. The Environment Clearance (EC) granted to the project/activity is strictly under the provisions of the EIA Notification, 2006 and its amendments issued from time to time. It does not



tantamount/ construe to approvals/ consent/ permissions etc., required to be obtained or standards/conditions to be followed under any other Acts/Rules/Subordinate legislations, etc., as may be applicable to the project.

II. Air quality monitoring and preservation

- i. The project proponent shall install 24x7 continuous emission monitoring system at process stacks to monitor stack emission as well as two Continuous Ambient Air Quality Station (CAAQS) for monitoring AAQ parameters with respect to standards prescribed in Environment (Protection) Rules 1986 as amended from time to time. The CEMS and CAAQMS shall be connected to SPCB and CPCB online servers and calibrate these systems from time to time according to equipment supplier specification through labs recognized under Environment (Protection) Act, 1986 or NABL accredited laboratories.
- ii. The project proponent shall monitor fugitive emissions in the plant premises at least once in every quarter through laboratories recognized under Environment (Protection) Act, 1986 or NABL accredited laboratories.
- iii. Appropriate Air Pollution Control (APC) system shall be provided for all the dust generating points including fugitive dust from all vulnerable sources, so as to comply prescribed stack emission and fugitive emission standards.
- iv. The project proponent shall provide leakage detection and mechanized bag cleaning facilities for better maintenance of bags.
- v. Recycle and reuse iron ore fines, coal and coke fines, lime fines and such other fines collected in the pollution control devices and vacuum cleaning devices in the process after briquetting/agglomeration.
- vi. The project proponent shall ensure covered transportation and conveying of ore, coal and other raw material to prevent spillage and dust generation.
- vii. Plant internal roads shall be concreted and a vacuum cleaner shall be used to regularly clean the roads.
- viii. The project proponent shall provide primary and secondary fume extraction system at all melting furnaces.
 - ix. Design the ventilation system for adequate air changes as per prevailing norms for all tunnels, motor houses, Oil Cellars.

III. Water quality monitoring and preservation

- i. The project proponent shall install 24x7 continuous effluent monitoring system with respect to standards prescribed in Environment (Protection) Rules 1986 as amended from time to time and connected to SPCB and CPCB online servers and calibrate these system from time to time according to equipment supplier specification through labs recognised under Environment (Protection) Act, 1986 or NABL accredited laboratories.
- ii. The project proponent shall monitor regularly ground water quality at least twice a year (preand post-monsoon) at sufficient numbers of piezometers/sampling wells in the plant and adjacent areas through labs recognised under Environment (Protection) Act, 1986 and NABL accredited laboratories.
- iii. Sewage Treatment Plant shall be provided for treatment of domestic wastewater to meet the prescribed standards.



iv. Garland drains and collection pits shall be provided for each stock pile to arrest the run-off in the event of heavy rains and to check the water pollution due to surface run off.

IV. Noise monitoring and prevention

i. Noise quality shall be monitored as per the prescribed Noise Pollution (Regulation and Control) Rules, 2000 and report in this regard shall be submitted to Regional Officer of the Ministry as a part of six-monthly compliance report.

V. Energy Conservation measures

i. Energy conservation measures may be adopted such as adoption of solar energy and provision of LED lights etc., to minimize the energy consumption.

VI. Waste management

- i. Used refractories shall be recycled as far as possible.
- ii. Oily scum and metallic sludge recovered from rolling mills ETP shall be mixed, dried, and briquetted and reused in melting Furnaces.
- iii. Kitchen waste shall be composted or converted to biogas for further use.

VII. Green Belt

- i. The project proponent shall prepare GHG emissions inventory for the plant and shall submit the programme for reduction of the same including carbon sequestration including plantation.
- ii. Project proponent shall submit a study report on Decarbonisation program, which would essentially consist of company's carbon emissions, carbon budgeting/ balancing, carbon sequestration activities and carbon offsetting strategies. Further, the report shall also contain time bound action plan to reduce its carbon intensity of its operations and supply chains, energy transition pathway from fossil fuels to Renewable energy etc. All these activities/ assessments should be measurable and monitorable with defined time frames", when PP comes for EC proposal. This study shall be formulated keeping in view of India's Net-zero commitment at the COP-26 Climate Summit.

VIII. Public hearing and Human health issues

- i. Emergency preparedness plan based on the Hazard identification and Risk Assessment (HIRA) and Disaster Management Plan shall be implemented.
- ii. The project proponent shall carry out heat stress analysis for the workmen who work in high temperature work zone and provide Personal Protection Equipment (PPE).
- iii. Occupational health surveillance of the workers shall be done on a regular basis and records maintained.

IX. Environment Management

i. The project proponent shall comply with the provisions contained in this Ministry's OM vide F.No. 22-65/2017-IA.III dated 30/09/2020.



- ii. The company shall have a well laid down environmental policy duly approve by the Board of Directors. The environmental policy should prescribe for standard operating procedures to have proper checks and balances and to bring into focus any infringements/deviation/violation of the environmental / forest / wildlife norms / conditions. The company shall have defined system of reporting infringements / deviation / violation of the environmental / forest / wildlife norms / conditions and / or shareholders / stake holders. The copy of the board resolution in this regard shall be submitted to the MoEF&CC as a part of six-monthly report.
- iii. A separate Environmental Cell both at the project and company head quarter level, with qualified personnel shall be set up under the control of senior Executive, who will directly to the head of the organization.

X. Miscellaneous

- i. The project proponent shall make public the environmental clearance granted for their project along with the environmental conditions and safeguards at their cost by prominently advertising it at least in two local newspapers of the District or State, of which one shall be in the vernacular language within seven days and in addition this shall also be displayed in the project proponent's website permanently.
- ii. The copies of the environmental clearance shall be submitted by the project proponents to the Heads of local bodies, Panchayats and Municipal Bodies in addition to the relevant offices of the Government who in turn has to display the same for 30 days from the date of receipt.
- iii. The project proponent shall upload the status of compliance of the stipulated environment clearance conditions, including results of monitored data on their website and update the same on half-yearly basis.
- iv. The project proponent shall monitor the criteria pollutants level namely; PM10, SO2, NOx (ambient levels as well as stack emissions) or critical sectoral parameters, indicated for the projects and display the same at a convenient location for disclosure to the public and put on the website of the company.
- v. The project proponent shall submit six-monthly reports on the status of the compliance of the stipulated environmental conditions on the website of the ministry of Environment, Forest and Climate Change at environment clearance portal.
- vi. The project proponent shall submit the environmental statement for each financial year in Form-V to the concerned State Pollution Control Board as prescribed under the Environment (Protection) Rules, 1986, as amended subsequently and put on the website of the company.
- vii. The project proponent shall inform the Regional Office as well as the Ministry, the date of financial closure and final approval of the project by the concerned authorities, commencing the land development work and start of production operation by the project.

The PP shall also put the information on the left over funds allocated to EMP and PH as committed in the earlier ECs and shall be carried out and spent in next three years, in the company web site for the information to public/public domain.
- x. No further expansion or modifications in the plant shall be carried out without prior approval of the Ministry of Environment, Forests and Climate Change (MoEF&CC).



- xi. The Regional Office of this Ministry shall monitor compliance of the stipulated conditions. The project authorities should extend full cooperation to the officer (s) of the Regional Office by furnishing the requisite data / information/monitoring reports.
- 9. The Ministry reserves the right to stipulate additional conditions, if found necessary at subsequent stages and the project proponent shall implement all the said conditions in a time bound manner. The Ministry may revoke or suspend the environmental clearance, if implementation of any of the above conditions is not found satisfactory.

Mandatory conditions

- 1) Installation of tamper proof digital water flow meter with telemetry on all the abstraction structure(s) shall be mandatory for all users seeking No Objection Certificate and intimation regarding their installation shall be communicated to the CGWA within 30 days of grant of No Objection Certificate.
- 2) Proponents shall mandatorily get water flow meter calibrated from an authorized agency once in a year.
- 3) Construction of purpose-built observation wells (piezometers) for ground water level monitoring shall be mandatory as per Section 14 of Guidelines. Water level data shall be made available to CGWA through web portal. Detailed guidelines for construction of piezometers are given in Annexure-II of the guidelines.
- 4) Proponents shall monitor quality of ground water from the abstraction structure(s) once in a year. Water samples from bore wells/ tube wells / dug wells shall be collected during April/May every year and analysed in NABL accredited laboratories for basic parameters (cations and anions), heavy metals, pesticides/ organic compounds etc. Water quality data shall be made available to CGWA through the web portal.
- 5) In case of mining projects, additional key wells shall be established in consultation with the Regional Director, CGWB for ground water level monitoring four (4) times a year (January, May, August and November) in core as well as buffer zones of the mine.
- 6) In case of mining project the firm shall submit water quality report of mine discharge/ seepage from Govt. approved/ NABL accredited lab.
- 7) The firm shall report compliance of the NOC conditions online in the website (www.cgwa-noc.gov.in) within one year from the date of issue of this NOC.
- 8) Industries abstracting ground water in excess of 100 m 3 /d shall undertake annual water audit through certified auditors and submit audit reports within three months of completion of the same to CGWA. All such industries shall be required to reduce their ground water use by at least 20% over the next three years through appropriate means.
- 9) Application for renewal can be submitted online from 90 days before the expiry of NOC. Ground water withdrawal, if any, after expiry of NOC shall be illegal & liable for legal action as per provisions of Environment (Protection) Act. 1986.

General conditions:

DISASTER MANAGEMENT PLAN/EMERGENCY RESPONSE PLAN

It can be stated that as the plant does not have any societal risk that requires Off-Site DMP. Only on-site risks are involved for which Emergency Response Plan is sufficient. The plant is located in an Industrial Area, which is under development. Only one industry of Badve Group (Auto Components) is operating. Most of the plots are vacant. The plant is located 1.38 km (N) from Kushkera CEPI boundary.

The nearest habitation is located more than 150 m away, Dhiriawas ki Dhani on the south east side of the plant. This is a small hamlet of 50-75 household – extension of the main Dhiriawas village located 2 km away. No school or hospital or police station is located within 1 km radiusof the plant. The industrial area is surrounded by single crop agriculture fields growing bajra. Kamalpur village is the large village located 1.2 km of the west side of the plant. Tapukara village is the largest village of the area, which is almost 2.5 km away from the plant in NE direction. Police station exists in Tapukara village. The predominant wind direction is from north west blowing towards south east. Ambulance and Fire Brigade is available in the adjoining Tapukara Industrial Area of RIICO. The facilities will be provided by RIICO in the Karoli Industrial Area. The roads of the Industrial Area are wide; 4-lane with median filled with green shrubs.

The objective of Disaster Management plan is to give a broad framework to tackle emergency situation for dealing with accident situation. It defines organizational responsibilities, actions, reporting requirements, broad key roles and responsibilities of personal. The overall objectives of the emergency plan will be:

- ✓ Ensure safety of workers
- ✓ To ensure localization of risk
- ✓ To minimize and reduce the effects of the accident on people and property.
- ✓ To prevent injuries by following proper onsite emergency plans.

There are various phases of Disaster.

Warning Phase

Emergencies /disasters are generally preceded by warnings during which preventive measures are initiated. For example uncontrollable build-up of pressure in furnace or weather forecast of storm.

Period of Impact Phase

This is the phase when emergency /disaster actually strike and actions are initiated to minimize the impact. The duration may be from hours to a day.

Rescue Phase

This is the phase when impact is almost over and efforts are concentrated on rescue and relief measures.

Relief Phase

In this phase, apart from organization and relief measures internally, depending on severity of the disaster, external help are also to be summoned to provide relief measures (like evacuations to a safe place and providing medical help, food clothing etc.). This phase will continue till normalcy is restored.

Rehabilitation Phase

This is the final and longest phase. During which measures required to put the situation back to normal as far as possible are taken. Checking the systems, estimating the damages, repair of equipment and putting them again into service are taken up. Help from revenue/insurance authorities need to be obtained to assess the damage, quantum of compensation to be paid.




Figure 7:1 Onsite Disaster Management Plan

Emergency Control Centre (ECC)

An Emergency Control Centre (ECC) is established from which emergency operations are directed and co-ordinated. Centre will be activated as soon as on-site emergency is declared. The ECC will consist of one room, located in an area that offers minimal risk being directly exposed to possible accidents. During an emergency, the Emergency Management Staff, including the main controller will gather in the ECC. Therefore, the ECC will be

equipped with adequate communication systems in the form of telephones and other equipment to allow unhampered organization and other nearby facility personnel.

The ECC will provide shelter to its occupants against the most common accidents; in addition, the ECC's communication systems will be protected from possible shutdown. The ECC will have its own emergency lighting arrangement and electric communication systems operation. The ECC will always be ready for operation and provided with the equipment and suppliesnecessary during the emergency such as:

- ✓ Hazard identification chart, All Emergency response plans
- ✓ Population around factory
- ✓ Internal telephone connections and External telephone connections
- ✓ A list of key personnel, with addresses, telephone numbers, etc.
- ✓ Hotline connection to district collector, police control room, fire brigade, Hospital etc.
- ✓ Public address system (PAS)
- ✓ List of dispensaries and registered medical practitioners around factory
- ✓ Area map of surrounding villages
- ✓ Note pads and ball pens to record message received and instructions
- ✓ The blown up copy of Layout plan showing areas where accident has Occurred
- ✓ Undated copies of the On-site Disaster Management Plan
- ✓ Emergency telephone numbers
- ✓ The names, phone number, and address of external agencies, response organizations and neighbouring facilities
- ✓ The adequate number of telephone
- ✓ Emergency lights
- ✓ List of fire extinguishers with their type no. and location, capacity, etc
- ✓ Personal protective equipment(PPE)
- ✓ Safety helmets
- ✓ Clock
- ✓ Material safety data sheets for chemicals handled at the facility
- ✓ Several maps of the facility including drainage system for surrounding area showing:
- ✓ Areas where hazardous materials are stored
- ✓ Plant layout
- ✓ Plot plans of storage tanks, routes of pipelines, all water permanent lines etc.
- ✓ The locations where personal protective equipment are stored

- ✓ The position of pumping stations and other water sources
- ✓ Roads and plant entrances
- ✓ Assembly areas
- ✓ Lay out of Hydrant lines

Roles and Responsibility

A team of following Essential persons shall be taking necessary action in case of emergency. The roles and responsibilities of these personnel are defined subsequently:

- ✓ Main Controller
- ✓ Site Incident Controller(SIC)
- ✓ Incident Controller (IC)
- ✓ Liaison Officer
- ✓ Communication Officer
- ✓ Observer
- ✓ Incharge (Security)
- ✓ Incharge (Medical)
- ✓ Shift Incharge (Security)

Main Controller

The Primary Controller is the employee who gives the first information about the incident/accident. He will be responsible for:

- ✓ To inform the Security office (Main Gate), & Engineers/Sr. Engineers / Shift In-Charges/HOD of Section of the aforesaid Department/Section from the nearest available telephone about the location and nature of incident.
- ✓ To assist rescue operation as well as clear obstruction, if any, in the same.
- \checkmark To carry out all instructions from Incident Controller.

Site Incident controller (SIC)

The Unit Head shall have overall responsibility for the factory and its personnel. In absence of Unit Head, Chairman OHS Committee shall assume the responsibility of Site Controller. His duties during emergency shall be:

✓ To assess the magnitude of the situation and decide if employees need to be evacuated from assembly points.

- ✓ To give necessary instructions to Liaison Officer, HOD(HR&A) regarding the help to be obtained from outside agencies like Fire Brigade, Police and Medical
- ✓ To advise Liaison Officer to pass on necessary information about the incident to News Media and ensure that the evidences are preserved for enquiry to be conducted by statutory authorities.

Incident Controller(IC)

The HOD of affected department shall have overall responsibility for controlling the incident and directing the personnel. Section In charge of the affected department shall assume the responsibility of Incident Controller(IC) in the absence of HOD of affected department. His duties during emergency shall be:

- ✓ To inform Communication Officer about the emergency, Control Center& Assembly point.
- ✓ To direct all operations` within the affected area with priorities for safety of personnel, to minimize damage to the Plant and environment and to minimize loss of material.
- ✓ To act as Site Controller till the later arrives.
- ✓ To advise and provide information to Fire Squad, Security Officer and Local Fire Services when they arrive.

To ensure that all non-essential persons are sent to the assembly point.

Liaison Officer

HOD (HR&A) shall be the Liaison officer. He shall be responsible for: -

- ✓ To contact Fire Brigade, Police, and Medical facilities on intimation from Site Controller & Controller &
- ✓ To ensure that the casualties receive attention.
- ✓ To inform relatives of the affected employee at the earliest.
- ✓ To arrange for additional transport if required.
- ✓ To arrange for relief of personnel & organize refreshment/catering facility, in case the duration of emergency is prolonged.
- ✓ To issue authorized statements to news media and ensure that evidence is preserved forenquiry to be conducted.

Incharge (Medical)

On receiving the information he will reach hospital immediately and take following actions: He will keep necessary first aid medicines and artificial respiration equipment ready.

✓ Inform doctors at other places to be ready, for attending serious injury, burn cases and foodpoisoning

Observer

✓ During Mock Drill for Emergency Situations they shall be placed at different locations in plant to note down the movement and action taken by people and give feed back to the Site Controller.

Communication Officer

In-Charge (Safety) shall act as Communication officer. He shall work from Control Centre andmaintain communication between relevant personnel. He shall be responsible for: -

- ✓ To apprise the site controller of the situation, based on the information received, suggest the evacuation of personnel from assembly points, if needed.
- ✓ To arrange for suitable persons to act as runners/messengers in case of failure of communication system.
- ✓ To carry out any other works as assigned by Site Controller/Incident Controller **Incharge Security**
- ✓ The Incharge (Security) shall guide the crew, according to the condition of emergency site, for the actions required to handle the emergency i.e. for fire fighting, removal of debris, arresting of dust, removal of oil soaked earth etc. He shall give instructions to Security Guards to cordon off areas as required by Incident Controller. He shall render all help to incident controller to handle the emergency and carry out the work as assigned to him.
- ✓ He shall be responsible for ensuring the discipline at control points and for preventing the entry of unauthorized persons inside the affected area as well as inside the factory during emergency.

Shift Incharge - Security

He shall be responsible for

- ✓ To arrange the necessary help as requested by Primary Controller.
- ✓ To inform Incharge (Security).
- ✓ To blow emergency siren, if instructed by the HOD (HR&A)/Incident Controller.
- ✓ To send Ambulance near accident area.
- ✓ To rush to the accident site with fire brigade along with available trained security persons.

The following system forms integral part of DMPAutomatic Fire Detection System Unattended vulnerable premises like electrical control rooms, cable tunnels, MCC, oil cellars, etc. will be provided with automatic fire detection and alarm systems.

Manual Call Point Systems

All major units and welfare/administrative building will be provide with manual call points for summoning the fire-fighting crew from the fire station for necessary assistance.

Alarm System

A hooter installed at the Security Office shall be blown alternately with high and low pitch for 2 minutes to indicate major emergency in the plant. In such case, all non-essential employees are expected to gather at assembly point i.e. Company's Main Gate/Time Office. Signal for the clearance of emergency shall be given by blowing the hooter continuously for one minute.

First Aid

Fully equipped Hospital with Ambulance Van is available. Doctors and nurse are available round the clock to handle any emergency in the plant. The Ambulance shall be periodically checked through preventive maintenance programme. To ensure that the system isstrictly followed, In-charge (Safety) shall cross check randomly once in a fortnight the preparedness of Ambulance as per the check list and counter sign.

- ✓ The injured shall be shifted to nearby hospital, as per the opinion of the Medical Officer.
- ✓ A list of First Aid boxes is available in every department as mentioned in ECC
- ✓ Medical Officer shall ensure that refilling is done on monthly basis and he shall maintain a record of refilling.
- ✓ The names & contact numbers of trained First Aiders are provided the same is displayed at all the prominent locations in the premises.
- ✓ In case of Injury caused due to Hazardous Chemicals, Material Safety Data Sheet (MSDS) available with the user department / Hospital shall be referred.

Mock Drill

For reviewing and assessing the level of preparedness, In-charge (Safety) shall conduct Mock trials twice in a year (one in each half) simulating the covered emergencies and will maintain records of the trials. The team of Prime & Deputy Responsible persons will review the records and events of the emergency preparedness trials along with the observations taken by the observer and report shall be put forward to the Site Controller. Corrective and Preventive measures, if suggested/directed, will be initiated and relevant records of the same are maintained. Fire drills will be exercised once in every six months under the leadership ofIncharge (Security). The records of Fire drill will be recorded & maintained.

The findings of the mock drills shall be used for improvements in preparedness and response. All team leaders shall be responsible for implementing the suggestions based on mock drill findings within reasonable time frame.

Training

Once a yearly basis class room training for fire fighting and mitigating measures to be adopted to reduce environmental impact & OHS risks, will be imparted covering at least 20% employee by the In-charge (Safety) and In-charge (Security). The records of the same are maintained.



विज्ञानियों ने अपनाई स्वदेशी विधि, साहीवाल नस्ल के अंडाणु व गिर के डीएनए का किया प्रयोग
